



## POSITION AVAILABLE: Invasive Species Field Technician

**Work location:** Meet at Marquette County Conservation District office, 780 Commerce Suite C, Marquette, Michigan; field work throughout Alger, Delta, Marquette, and Schoolcraft Counties in the Lake to Lake Cooperative Invasive Species Management Area (L2L CISMA). **Starting date:** June 3, 2019

**General Conditions:** This is a part-time, seasonal position, averaging 32 hours per week from early June through late September. Work schedule will average four days per week. Duties include approximately 95% field responsibilities and 5% office and data work; the mix may vary due to weather and seasonal considerations. Employee will be primarily supervised by the CISMA Coordinator and District Manager.

### Essential functions include:

1. Assist with invasive species field activities
  - a. Survey, map and monitor infestation sites
  - b. Conduct manual and chemical invasive species management techniques
2. Assist with invasive species data management
  - a. Use handheld GPS unit to collect data
  - b. Enter field data according to Marquette County Conservation District data management protocols
3. Related duties
  - a. Lead conservation interns on field days, with assistance from the CISMA Coordinator
  - b. Assist with outreach events at various workshops and meetings
  - c. Perform other related duties as assigned by supervisor

### Qualifications:

1. Education: Bachelor's degree in Biology or Ecology or current biology/natural resources/agriculture students or persons with background in natural resources preferred. Coursework related to GIS, botany, limnology, entomology, or ecology is a plus.
2. Experience: Field experiences in invasive species identification and control, GPS & map use, and public speaking a plus.
3. Computer skills: Experience with MS Excel, BaseCamp, and Google Earth a plus.
4. Other: Applicant must:
  - a. Have reliable personal transportation for work-related use; must maintain valid Michigan driver's license.
  - b. Be able and willing to work efficiently outdoors in a variety of conditions and terrains.
  - c. Be able to work cooperatively with District and Agency personnel and the general public.
  - d. Exhibit excellent attention to detail in collecting and recording field data.
  - e. Be prepared to wear personal protective equipment whenever applicable.
  - f. Currently possess or willingness to become Michigan certified pesticide applicator

**Compensation:** \$14-\$16/hr dependent on experience and mileage reimbursement for travel to required training and field sites.
